Minutes for September 17, 2007

Meeting called to order at 7:15 PM

1. Minutes from the last meeting were read and accepted.
2. Discussed upcoming Tom Clark ride to correctional facility. Elvin stated that the current consideration is for a ride and tour of the Allegheny County Jail. Nothing is definite at this time and information will be emailed to members when available.
